6. Resolution No. 2021-4 Maintenance Reserve Withdrawal

RESOLUTION No. 2021-4 MAINTENANCE RESERVE FOR MAINTENANCE EXPENDITURES

WHEREAS, The Alloway Township Board of Education, by this Resolution, authorizes the withdrawal of up to \$20,000 from the Maintenance Reserve Account for appropriation into the required maintenance account lines, and

WHEREAS, Funds from the Maintenance Reserve will be used on required maintenance activities for a school facility as reported in the comprehensive maintenance plan pursuant to N.J.A.C. 6A:26A-4, and

WHEREAS, Funds withdrawn from the maintenance reserve account are restricted to required maintenance appropriations and is consistent with the requirements of N.J.A.C. 6A:23A-14.2, and

WHEREAS, The Board of Education shall ensure that the maintenance reserve account balance does not, at any time, exceed four percent of the replacement cost of the school district's school facilities for the current year. If the account exceeds this maximum amount at June 30th, the district board of education shall reserve and designate such excess in the subsequent year's budget,

NOW THEREFORE IT BE RESOLVED, the Alloway Township Board of Education authorizes the withdrawal of up to \$20,000 from the Maintenance Reserve Account for appropriation into the required maintenance account lines.

7. Termination - Shared CST MOU w/ UPS

The Board approve the termination of the 2020-2021 Memorandum of Agreement for Child Study Team Services with the Upper Pittsgrove School District effective January 10, 2021. Furthermore, the Board approve the revised 2020-2021 contracted amount of \$35,000 for the MOA for CST Services with UPS for the term September 1, 2020 through January 10, 2021. Alloway and UPS entered into a shared service agreement with the Woodstown-Pilesgrove Regional School District for CST services for the remainder of the 2020-2021 school year; therefore, this contract is no longer necessary.

8. Technology Purchase - Chromebooks

The Board approve the purchase of 100 Dell Chromebooks with the Premium Protection Plan with accidental damage and Google Chrome Management Console License, along with 100 Chromebook Cases through CDW-G under contract: Technology Supplies and Services #ESCNJ18/19-03(18/19-03) in the amount of \$39,289.00.
