Dr. Agnew stated that this committee could also function as the Citizens Advisory Committee. Mr. Morris stated he would like to see the Citizen Advisory Committee expanded to include more board members and more parents. Dr. Agnew reported that there are specific goals for this committee and that the option of increasing its members can be explored when a permanent superintendent is hired.

## ESEA Accountability Corrective Action Plan

The ESEA (Elementary Secondary Education Act) Accountability Corrective Action Plan for 2016. This plan is required due to not attaining the state's required participation rate of 95% on the 2015-16 administration of the PARCC test. Alloway had a participation rate of 91.1 (Page 5895)

Ms. Decktor asked if this rating affects QSAC in any way? Dr. Agnew responded no, unless students not participating in the PARCC testing are all in the top percent of test takers (which could change the results of the overall test scores).

Mr. Dyer asked if our school was being penalized and held accountable for a low participation rate in PARCC testing, when parents can opt out. Dr. Agnew stated that a letter will be sent home to parents of students not participating to try to encourage more participation. There is no "opt out" but parents may refuse to send students to school to participate in the testing.

#### Request for School Nurse Internship

Tanya Craycraft, currently enrolled in Wilmington University MSN program, to shadow the Alloway School nurse, Mrs. Whelan, for 80 hours to fulfill course requirements. Ms. Craycraft would start her hours the last week of January, 2017.

# Placement of Student Teacher

The placement of Ms. Katie Lynn McCarthy, a Health and Physical Education major at Rowan University, with Mr. Mark Jaep, Physical Education teacher at Alloway School. Ms. McCarthy will complete her field experience in Health and Physical Education and she will also be exposed to grades

6-8. Ms. McCarthy will visit 8 hours per week, over the course of 2 days per week, from January 30th - March 8th.

#### COMMITTEE REPORTS

Woodstown-Pilesgrove Report-Mr. Morris

(Page 5917)

Mr. Donohue discussed the energy tax that is generated at the PSE&G Facility in Lower Alloways Creek. This energy tax is not included in the state budget and is not allocated to any districts or municipalities in Salem County other than Lower Alloways Creek Township. Mr. Donohue stated that over \$1 billion is generated annually but we get only .5% of those funds. State representatives should be contacted to express our concerns. It was suggested that Senators Steven Sweeney and John Burzichelli be contacted along with Assemblyman Adam Taliaferro, to discuss this funding situation. It was also suggested that the Alloway Township Committee be asked to join us in our objection to the usage of the energy tax collected from PSE&G. Mr. Donohue and Mr. Dyer agreed to serve on the committee to investigate this further.

# PUBLIC COMMENT-OPEN

Mrs. Karen Wildermuth, Teacher, asked if anything has been started in finding a permanent administrator? Mr. Dennison reported there is a process which we are following with the NJSBA. There will be an evening meeting scheduled at some point asking for input from the staff and community. Mrs. Joyce commented that the deadline to apply for the Superintendent vacancy is by midnight on January 24, 2017. Mrs. Joyce will contact Mrs. Terri Lewis to see how many applicants have applied.

Mr. Harry Harding, community member, asked if a parent representative serving on the SIT Committee can be an employee of the school. Dr. Agnew responded yes.

Mr. Richard Kaufmann, teacher, asked about the HIB report noting there were zero incidents reported but the board agenda shows there were four student suspensions in December. Dr. Agnew stated that none of the incidents relating to the suspensions in December met the criteria of bullying and therefore would not be included on the HIB report.
